Central Texas TeleCommunications College Scholarship Program 2024

Central Texas TeleCommunications offers a college scholarship program to assist graduating high school seniors who desire to further their education. Applications may be requested beginning January 31st of each year.

Amount and Disbursement of Scholarships

A scholarship of \$2,500 each will be awarded to one qualifying student per school in the Central Texas TeleCommunications service area. The full amount of the scholarship will be paid directly to the post-secondary educational institution upon receipt of proof of enrollment for a minimum of 12 hours, or full time status. Proof of enrollment must be provided by July 1st for the Fall Semester or December 1st for the Spring Semester in order to be processed and received by the school prior to the beginning of the semester. If the student does not attend the Fall Semester, the scholarship will be paid during the Spring Semester. Scholarship funds that remain unclaimed by a student within 12 months of the award date will be forfeited.

Type and Location of School

The \$2,500 scholarship can be used for any educational institution of higher learning. This will include any junior college, college, university, technical, trade or vocational school.

Qualification Criteria

The recipient must be a high school senior who is the dependent, and resides in the home, of an active customer of Central Texas TeleCommunications. An active customer is defined as a subscriber in good standing, receiving local **wireline telephone or internet service** within the Central Texas TeleCommunications service area as of January 1, 2024. Dependents of Employees or Directors of Central Texas TeleCommunications or its affiliate companies are not eligible to apply.

Scholarship Application

Scholarship Announcements

Scholarship recipients will be announced at the High School Awards Ceremony, Graduation Ceremony, or other event as determined by the local school district of the selected recipients.

Statement of Nondiscrimination

SCHOLARSHIP APPLICATION REQUIREMENTS

- ✓ Applicant must be a high school senior and dependent residing in the home of an active member receiving service from Central Texas TeleCommunications. An active customer is defined as a subscriber in good standing, receiving local wireline telephone or internet service within the Central Texas TeleCommunications service area as of **January 1, 2024**.
- ✓ Within 12 months of the award date, recipient must use scholarship to attend an accredited junior college, college, university, technical, trade or vocational school on a full time basis, or a minimum of 12 hours.
- ✓ Applicant must have a seven semester cumulative grade point average of **2.5 or equivalent on a 4.0 scale** for the 9th-12th grade.
- ✓ Applicant must submit:
 - Completed Application (signature required)
 - School Certification
 - Official High School Transcript, and College Transcripts if applicable
 - 400-600 Word Essay
 - Letter of Recommendation
- ✓ Essay Requirements: In a 400-600 word essay, describe **“Why Central Texas TeleCommunications Should Invest In My Education”**.
- ✓ **Incomplete or late applications will not be considered.**
